4 – All team members will self-monitor their symptoms, like fever, cough and breathing problems and immediately contact the Race Organizer and/or the COVID-19 doctor through the number **+351 911 756 700**.

5 – All team members accept, whenever invited by the organization, to participate in social and educational initiatives to raise awareness among all sports agents and society for the prevention and control of COVID-19.

6 - I am aware that the consequences of providing false, incomplete or inaccurate information will be attributed to me.
